# **Comparative Disability Law**

#### I. Class Description

*Comparative Disability Law* (2 sem. hrs. cr.). This course will introduce the student to existing and developing laws and policies designed to protect individuals with disabilities from discrimination in employment, and in public and private programs and services. Its primary focus will be to examine the Americans with Disabilities Act of 1990 (ADA) as an example that other countries -- such as England, India, Germany, France, and Japan -- and the United Nations have considered in developing notions of disability rights. It also will examine other U.S. laws, such as the Rehabilitation Act of 1973, that have been used as the basis in other countries for disability rights policies. In addition, this course will examine research in areas of law and policy involving the rights of persons with disabilities based on projects related to the activities of the Law, Health Policy, and Disability Center (LHPDC) at the College of Law (see www.its.uiowa.edu/law for such projects).

## **III.** Grading

Your grade will have two components.

1. The bulk of your grade (90%) will be based on a final based on topics discussed in class. The final will be a two hour exam, given on Friday, June 21, and likely be analysis of a hypothetical or actual case with issues relevant to the class. The final will be graded anonymously and **limited to 10 typed pages** in length (with 12 point font, double spaced, and one inch margins), not including endnotes and/or references (other details will be provided at a later date).
